
#### **Directions to the Packard Center**

#### Citizen of the Year

Mollie Morison-Loeffler will be honored as the Federation's 2010 Citizen of the Year at the Federation's annual banquet. The banquet will be held on Sunday, May 15, 2011, at the Tysons Crowne Plaza. The banquet is co-sponsored by SAIC.

Mollie Loeffler is known throughout Fairfax County as a real "firecracker." Her energy and enthusiasm for creating community and taking action are renowned. She was selected for her leadership in re-establishing her community association, winning two \$5000 grants from the Fairfax County Neighborhood Enhancement Partnership Program for both her community and a local county park. Mollie's work then led to a bigger platform and she spearheaded the reconstituting of the long dormant Mason District Council. Under her leadership, the Mason District Council has tackled major zoning issues, such as overcrowding and littering, by creating a network of resources that include citizens associations and the county, working on solutions to common problems facing the community.

"Mollie's positive and energetic civic leadership is exemplary work of what we can accomplish when we empower ourselves to act on behalf of our communities" said Tania Hossain, Federation president.

Charlie Dane of Annandale will receive a 2010 Citation of Merit at the banquet. Dr. Dane has a long history of public service to Fairfax County. He has been associated with the Fairfax County Federation of Citizens Associations for many years, briefly serving as Chair of the Land Use Committee, and then later as First Vice President. For almost ten years, he served as Chair of the Federation's Education Committee. He served for two years as co-chair and continues to serve as a member of the Fairfax County School Board's Advisory Committee of Human Relations. He is a member of the Fairfax County Public School Superintendent's Business and Community Advisory Council.

Special Gratitude Awards will be presented to <u>Anthony Griffin</u>, Fairfax County Executive, and <u>Bill Lecos</u>, past president and CEO of the Fairfax Chamber of Commerce and a member of the Tysons Land Use Task Force.

Anthony H. Griffin, as Fairfax County Executive, provided Fairfax County with solid leadership, good fiscal stewardship and the ability to motivate and inspire the county workforce. He has distinguished Fairfax County as a world-class center of commerce and trade and the technology hub of the East Coast. Fairfax County is well known as a wonderful place to live, work and play and Griffin's leadership has ensured that the quality of life remains high, despite the new challenges of the 21st century. His tenure has encompassed projects both large and small that will have a significant impact on Fairfax County and the region for years to come, including: Tysons Corner Redevelopment, Dulles Rail, McConnell Public Safety and Transportation Operations Center, Strategic Plan to Prevent and End Homelessness, Code of Ethics Update, Lorton Land Reuse Plan and the Chesapeake Bay preservation ordinance.

<u>Bill Lecos</u>, as past president and CEO of the Fairfax Chamber of Commerce and a member of the Tysons Land Use Task Force, played a central role in the citizen-based effort to re-

plan Tysons Corner. Thanks largely to Bill's leadership, the Board of Supervisors had the opportunity to approve a visionary Comprehensive Plan amendment that enabled historic investments in Tysons' transportation infrastructure while spurring development of a new, green housing stock. Bill ensured that this re-planning effort helped business in the County and had the support of the business community. Bill has been involved in public affairs in our region for two decades, as President of the Restaurant Association, Senior Vice President of Policy at the Washington Board of Trade, and President and CEO of the Fairfax Chamber of Commerce. Bill played a central role building broad-based support for transportation and land use policies that would improve the quality of life for Fairfax residents.

Katharine Weymouth, Chief Executive Officer, Washington Post Media and Publisher, The Washington Post, will be the keynote speaker. The banquet is open to all. We hope many of you will come to honor these much deserving people and to hear this famous speaker. #### **Funding Infrastructure for High-Density Development**

The County has (tentatively?) decided to have the taxpayer pay 58% of the infrastructure costs for the Tysons redevelopment, with the developers paying 42%. The citizens associations want the developers to pay 75% as was done along Route 28.

#### **Membership Meeting Minutes**

Thursday, March 17, 2011

#### Draft to be submitted for approval, 4/14/2011

The March 2011 meeting of the Membership of the Fairfax County Federation of Citizens Associations was called to order by President Tania Hossain at 7:38 p.m. in the Packard Center, Annandale. The attendance list is attached to file copy of the minutes.

The two program items literally consumed the entire evening, with only a few other topics being addressed briefly. Reports from the Transportation Committee, the Webmaster, and the Braddock and Sully District Representatives were not given orally at the meeting but are published in the minutes.

#### <u>Program 1: Fairfax County's FY2012 Advertised</u> Budget — Anthony Griffin, County Executive

Mr. Griffin talked to the membership in a conversational setting for over an hour, explaining his view of the budget and answering questions. Information on the county's advertised FY 2012 budget is available at <a href="https://www.fairfaxcounty.gov/dmb/">www.fairfaxcounty.gov/dmb/</a>. President Hossain expressed the Federation's gratitude for the informative presentation and presented Mr. Griffin with a Federation coffee cup.

#### **Program 2: Federation's Budget Resolution**

Charlie Hall chaired this section of the meeting to review, amend, and adopt the Federation's Budget Resolution. The starting position was the draft budget resolution that was approved by the Federation's board on March 17. The results from this meeting will be documented fully in the budget resolution that Charlie will usher through publication and so will not be recorded in detail in these minutes.

Highlights of the budget resolution include:

Praise for the Fairfax County government for steering prudently through a time of extended fiscal challenge.

As the economy recovers, in future years some prior cuts in services should be restored.

The current public budget process needs improvement: a more transparent discussion of long-term budget issues and better means for public input, including a county-wide citizens' budget committee and a lengthier budget approval period.

A recommended residential property tax rate of \$1.075 per \$100 assessed value. This rate is \$0.015 less than the \$1.09 rate proposed in the advertised budget and \$0.01 greater than a "revenue neutral" rate of \$1.065.

The Federation recommends funding:

An increase in the school transfer with a message to the school board that the Board of Supervisors expects the additional funds will be used to support implementation of both full day kindergartens at all schools beginning in the 2011-2012 school year and online testing for SOL.

A reserve that would be available for use should the human services funding expected from the Federal and Commonwealth government transfers be less than forecast.

#### **Administrative Topics**

**Minutes:** The membership approved the minutes of the February 17, 2011, membership meeting.

**Treasurer's Report:** Scott Schlegel distributed the treasurer's report to board members via e-mail prior to the meeting. Due to the focus of the meeting on the county's budget, the report was not re viewed.

Vacancies on County Boards and Commissions: Second Vice President Don Hinman is recruiting for three Federation representatives to other organizations: Citizens Corps Council, Community Action Advisory Board, and the Engineering Standards Review Committee. Don noted that people representing the Federation do not have to be from associations that are Federation members. Don distributed a handout which is Attachment #1 to these minutes. (See the textbox on Page 7 of this bulletin.)

### Transportation — Carey Campbell, Roger Hoskins, and Jeff Parnes

The following information was not given in meeting but was disseminated by Jeff through these minutes.

Alternatives for Improving Roadway Services:

The Board of Supervisors has asked staff to conduct a study

evaluating Alternatives for Improving Roadway Services in Fairfax County. Virginia is one of four states in which the construction, maintenance and operation of roads are a state function rather than a county function. Cities have always had local control, and Arlington and Henrico counties negotiated an arrangement in the 1930s for them to maintain control (the state assumed the responsibility during the Great Depression, as many counties could no longer afford to do so). Recently several other counties have negotiated with VDOT to assume local control, although their arrangements do not provide them with the same level of funding as Arlington and Henrico counties receive.

Each jurisdiction that has either retained or assumed responsibility reports satisfaction with local control. Each also reports that they spend more for construction, maintenance and operation then the funds provided by the state. In the report referenced above the county reported that as VDOT does not provide services by county, VDOT was unable to provide costs specifically attributed to Fairfax County, but could only provide information about the Northern Virginia district that includes Fairfax, Loudoun and Prince William counties.

Assumption of these responsibilities therefore involves unknowns, as even the level of service provided by the state is unquantifiable. The Fairfax County Transportation Advisory Commission (TAC), of which Jeff Parnes chairs, acting as a citizen's review board by the request of the Board of Supervisors, provided its comments to the Board. The review stressed the uncertainty of funding, of the level of service we are receiving by the state, of the level of service that our residents, used to a high-level of responsiveness from the county in all it does, would expect if the county took over the responsibility. The TAC recommended that the county explore a pilot program before it took over responsibility for the whole county.

Already at least one supervisor has publicly announced support for assumption of responsibility. This will be a matter for the board to decide, weighing the benefits of local control of operations, design and responsiveness to citizen concerns against the unknowns of both ongoing costs and one-time set up fees, service levels provided and expected and budget constraints.

No impact to the 2012 budget is expected, but future years' budgets will see significant impacts if the board decides to go forward with local control.

Transportation Committee web site updates.

The committee's page has links to:

- The 4th Circuit of the US court of Appeals reached a decision on 23 March 2011, upholding the lower Court in dismissing all of the claims brought by Chris Walker challenging the Dulles Rail Project. That brings to an end the last of the lawsuits challenging one or another aspect of the Dulles Rail Project. The Circuit characterized Walker's claims as being "generalized grievances" which did not present a true controversy that the Court could resolve but instead raised policy issues not appropriate for the Court. The only claim that the Court addressed directly was one that alleged that MWAA had violated Virginia's Freedom of Information statute. The Court affirmed the lower Court's conclusion that the Airports Authority, as an independent political body, was not subject to Virginia's FOIA statute.
- The Metropolitan Washington Airports Authority (MWAA) met on 16 March to consider funding constraints on Phase 2 of the

Dulles Rail project. They discussed:

- Independent Advisory Panel Presentation Phase 2 Dulles Alternatives
- Contract Packaging Options for Phase 2 of the Dulles Corridor Metrorail Project.
- Recommendation on Alternative Airport Alignments at Dulles International.
- Dulles Corridor Rail Association (DCRA) President Patty Nicoson presented Ten Things Every Business Needs to Know about Dulles Rail to DATA on 16 March 2011
- The Transportation Advisory Commission (TAC) was briefed on the Safe Route to School Program by the Washington Area Bicyclist Association on 15 March 2011
- The Board of Supervisors Transportation Committee on 1 March 2011 received these presentations:
  - The I95 HOT Lanes proposal by VDOT
  - Staff study on Alternatives for Improving Roadway Services
  - The Fairfax County Transportation Advisory Commission, acting as a Citizens Review Committee, review of the Staff's proposal on Alternatives for Improving Roadway Services
  - Proposed Transportation Funding Policy Changes by FDOT
- The Board of Supervisors Transportation Committee on 1 February 2011 received these presentations:
  - VDOT and the Federal Highway Administration gave a joint presentation on the status of BRAC transportation Improvements
  - BRAC Successes and Remaining Issues by VDOT
  - Gina Arlotto, of the Washington Area Bicyclists Association, briefed on the Safe Routes to School program in Fairfax County
- The Transportation Advisory Commission on 4 January 2011 received an update on the I-495 HOT Lanes Project.
- Mark Tipton, the FCFCA representative, Trails and Sidewalks Committee, on 16 March 2011 provided:
  - Transportation Projects Status Report for February regarding roads, sidewalks, trails, and bus shelters
  - FC Park Authority presentation of current and planned trail improvements. Most of the trail projects are already funded from park bonds, federal funds, etc. and some are under construction. However, a few of the projects are not yet funded, or need neighborhood support to proceed.

#### <u>Association Complaint Process – Ombudsman</u> Staff Reviewing Proposed Rule

A proposed rule that would require common interest communities (CIC), such as HOAs and Condominium Associations, to develop and publish procedures for handling resident complaints against boards of directors is under review by the staff of Virginia's Common Interest Community Ombudsman. The intent of the rule is to ensure that common interest community boards have clearly articulated processes for residents to pursue complaints against the board of their association. Under the proposed rule, the internal community complaint process should be completed, and a "final adverse decision" rendered, before a resident can file a complaint against the board with the state CIC Ombudsman.
