Directions to the Annandale Community Park Picnic Shelter


Take I-495 (Capital Beltway) to Route 236 (Little River Turnpike, going east toward Annandale) go east 0.4 miles to first traffic signal

Membership Meeting Minutes

Thursday, May 19, 2011

Draft to be submitted for approval, 6/16/2011

The May 2011 meeting of the Membership of the Fairfax County Federation of Citizens Associations was called to order by President Tania Hossain at 7:40 p.m. in the general meeting room of the Packard Center, Annandale.

Meeting Opening

The Federation presented **Clark Tyler** with his permanent Citizen of the Year award along with the memory album. In his remarks, Mr. Tyler thanked the Federation for its work in the community and said that he looks forward to continued work with the Federation in the coming years.

Per the bylaws, the election of 2011-2012 Officers was held towards the beginning of the agenda. On behalf of the Nominating Committee, Art Wells offered the Nominating Committee's report and presented 2011-2012 Officers slate to the Federation membership: Tania Hossain - President, Don Hinman - 1st VP, Joe Gibson – 2nd VP, Ed Wyse – Recording Secretary, Scott Schlegel – Treasurer, and Fred Costello – Corresponding Secretary. The nomination was open to the floor. No other nomination was offered and the nomination process was closed. The Federation membership unanimously approved the Nominating Committee's proposed slate. President Tania Hossain congratulated the incoming officers and thanked the Nominating Committee on its excellent work.

Program: Report from Richmond

The report from Richmond was presented by **State Senator Dave Marsden** (D-37th District) and **Delegate Mark Keam** (D-35th District). The general agreement was that the General Assembly session addressed difficult legislative matters for the Commonwealth in a collegial manner.

Senator Marsden gave us an overview of the shortfall in transportation funding and the need for a long term funding solution, insurance coverage of the autism spectrum disorder, smaller group homes, community-based mental health care, prison reform and the closure of juvenile detention centers. Senator Marsden also impressed upon us how we are living in better times as Virginians. To illustrate that, he drew the following comparison: In 1948 with a population of about 40,000, there were 40 traffic related deaths and 20 homicides and in 2004 with a population of about one million, there were 40 traffic related deaths and 15 homicides in Fairfax County. Senator Marsden left us with a positive outlook on the inner workings of the next General Assembly and asked us to stay engaged with him, especially during the next session when the General Assembly will be working on Governor McDonnell's first budget as the next biennial budget.

Delegate Keam gave us an overview on the current redistricting process and its impact on Fairfax County residents. He recommended the Division of Legislative Services redistricting website for details on the changes in representation (http://redistricting.dls.virginia.gov/2010/.) Delegate Keam discussed the concept of structured reform as pertains to the Commonwealth's budget and asked us to stay tuned to Governor McDonnell's first biennial budget for these structural reforms.

He informed us that May 2011 was the start of the first wave of the Silver Tsunami (baby-boomer retirements) and that we need to make sure that we are prepared in our human services delivery. He also stressed the importance of higher education and that regardless of the ebb and flow in generations on higher education, funding for higher education must remain a priority for the Commonwealth. Delegate Keam also discussed transportation funding and stressed the need for diversified revenue sources. Delagate Keam's handout has been entered into the minutes.

Administrative Topics

Minutes: The membership approved the minutes of the April 21, 2011, membership meeting. Tania Hossain is serving as Recording Secretary Pro Temp for this meeting.

Bulletin (Newsletter): Newsletter articles are due to the editor by May 23.

Treasurer's Report: Scott Schlegel submitted the treasurer's report by e-mail and reports that the Federation is in the black in net income for the current year. This is the first time in five years that the Citizen of the Year Banquet has provided some income for the Federation. A motion to receive and file the report was made, seconded, and adopted/approved unanimously.

Old Business

2010 Citizen of the Year (COY) Banquet: Jeff Parnes, COY Chair, reported that the 2010 COY event was successful in terms of recognizing many dedicated leaders who volunteer in the community and in the increase in the number of guests. We had an excellent guest speaker in Katharine Weymouth, Chief Executive Officer, Washington Post Media and Publisher. We should give more time to the planning of COY and advanced execution. Jeff has already started in that direction. We have to continue to make this a signature event for the Federation. 2010 COY Banquet financial results: Total Income \$8,395.00; Total Expense: \$6,493.00; Net Income gain of \$1,902.00. Many thanks again for the co-sponsorship of SAIC.

New and Miscellaneous Business

Federation Annual Picnic: The Federation's Annual Picnic and Installation of Officers will be on Thursday, June 16. The Federation held its election at the May 19 membership meeting.

Policies and Procedures: Bill Hanks circulated the Policy and Procedures cover sheet for Board adoption at its May 26 meeting. Working documents were circulated in advance of the meeting.

No Board or Committee reports were given.

Adjournment

The meeting adjourned at 9:35 pm.

In addition to the Engineering Standards Review Committee, the Federation has representation on seven others: (1) Citizen Corps Council, (2) Criminal Justice Advisory Board, (3) Community Revitalization and Reinvestment Advisory Group, (4) Information Technology Policy Advisory Committee, (5) Trails and Sidewalks Committee, (6) Community Action Advisory Board, and (7) Airports Advisory Committee.

The Federation has representation on three of these (Advanced Academic Programs, Human Relations, and Students with Disabilities), as well as the Superintendent's Business and Community Advisory Committee.

Base Realignment and Closure (BRAC)

Base Realignment and Closure (BRAC) is the process the U.S. Department of Defense uses to reorganize its military installations to adapt to changing circumstances. The 2005 BRAC law will result in the transfer of 14,000 to 19,000 Department of Defense jobs to Fort Belvoir by Sept. 15, 2011.

A Final Environmental Impact Statement and Record of Decision regarding the BRAC moves to Fort Belvoir was released in 2007. According to the Record of Decision, the National Geospatial-Intelligence Agency will bring 8,500 employees to the Engineer Proving Ground. Relocations of Army leased space and the new DeWitt Medical Center will bring approximately 5,500 employees to the main post of Fort Belvoir. An additional 6,400 jobs associated with BRAC 133, including Washington Headquarters Service (WHS) are to be located at the Mark Center in Alexandria. On May 26, 2011, the U.S. House of Representatives voted, as part of the 2012 Defense authorization bill, to delay the move of thousands of government employees to the Mark Center in Alexandria. The legislation includes a cap on parking at the newly completed Mark Center in an attempt by Rep. Jim Moran to force the Department of Defense to pay for traffic abatement (new exit ramps on I-395, for example). The Senate is expected to take up the bill late this summer.

Community Association Issues

The following is a list of community association issues and problems identified during the monthly meeting of the Lee District Association of Civic Organizations (LDACO) held on May 25, 2011.

These topics may be addressed by future meetings or workshops organized by LDACO and/or the Federation, or by other educational initiatives undertaken by the CASC. If citizens have additional issues they would like to see addressed, they should contact CASC chair Don Hinman at FedAssociationServicesChr2010@fairfaxfederation.org

Issues for civic associations and issues of general interest.

- Insurance needs of civic associations (i.e., what if someone is hurt at a community event?) Insurance needs of officers of civic associations.
- 2. Pros and cons of incorporation for a civic association. Does incorporation have an impact on civic association liability?
- Lake management issues for communities with lakes, eg, legal liability for injury or death, checking water quality, cleaning and maintenance, sediment and dredging, stocking with fish, etc.
- 4. Dealing with language barriers. Should CAs do outreach in other languages? Is there a downside? How to communicate if people have limited literacy in their own language, as well as limited or no literacy in English?

Issues for HOAs and Condo Associations

- 1. Techniques for improving HOA assessment collection
- 2. Amending covenants pros and cons; how to do it. What are elements of good covenants?
- 3. Understanding situations where HOAs have only limited rights to restrict, e.g. satellite dishes.
- 4. How to recruit new board members
- 5. Resale disclosure packets. What should be in the packet? Questions to ask a manager that handles the packets. Does website availability of HOA/Condo governing documents have an impact on the disclosure packet preparation?

Sun-Wise and Sun-Safe

EPA encourages residents to:ce the Slip, Slop, Slap and

- Wrap sun-safety tips:
- Slip on a shirt, preferably with sleeves;
- Slop on SPF 15+ sunscreen generously;
- Slap on a hat; and
- Wrap on sunglasses.

EPA's SunWise program (www.epa.gov/sunwise) also recommends that families seek shade during the sun's peak hours between 10 a.m. and 4 p.m. Checking the UV Index to plan outdoor activities is also key for identifying times that pose the greatest risk for overexposure to the sun.
