County Carry-Over Budget: \$220M

The County budget includes approximately 3% in contingency funds that are designed to provide funds if the County revenues are lower than forecast. The 3% and the increased revenue received during FY2014 amount to over \$220M, which will be added to the approved FY2015 budget. On **September 9**, **2014**, **at 10:30 am**, the Board of Supervisors will hold a public hearing on the Carry-Over Budget. At the same meeting, the Board of Supervisors will vote on County Executive Ed Long's recommendations on how the funds are to be spent. For example, the August issue reports the following relative to one year ago:

- Unemployment rate decreased by 0.3%, to 4.4%.
- · August Sales tax receipts declined 1.6%.
- Average sales price of all homes that sold in July decreased 0.5%
- Number of active listing of homes for sale increased 57.2%.
- Non-farm employment in Northern Virginia increased 1%.

The site has graphs covering 12 months in each of these and other categories.


Although both detached and attached homes saw price increases, more attached homes sold; therefore, the average was lower (third bullet).

Up for the vote: Library Resolution

At the August 14 meeting, the Federation Board approved the following resolution. The Membership will vote on the resolution at the Sept 18 meeting.

Background

A comprehensive collection inventory of Fairfax County Public Library (FCPL) collection has not been done since 1988.

Total collection numbers in internal Collection Overview documents cannot be reconciled since 2006 or even yearly. There is a 66,000 volume discrepancy in the FY14 document alone. Additionally, there are discrepancies in the budget numbers in official library documents. The 2011 IMLS (United States Institute of Museum and Library Services) report lists the FCPL budget as \$32.9M. The Library Journal Star Library rating (published in the Washington Post in 2014) for 2011 records a FCPL budget of \$35M. Fairfax County budget documents record the 2011 library budget as \$25M.

Techniques for the massive book dumping that occurred October 2012 to September 2013 has resulted in gaps in the recording of collection data. Books are on the shelves that are not in the catalog.

There is no way to verify the status of books currently held at Technical Operations. Prior to discard, books are held at Technical Operations. All of the increase of holdings for FY14 are in Technical Operations. The branches showed an overall decrease in holdings, per Terry Maynard's August 2014 Cumulative Collection Overview.

The Library Board has convened a committee to begin a national search for a new Library Director. In order to go forward, the new Library Director will need accurate data to assess what is needed to stabilize and rehabilitate the collection and to actualize a workable plan for the future of the library.

Deputy Library Director Melanie Quinn has stated that about \$100,000 per year from Friends of Library groups' ongoing book sales goes into the system gift fund and is used by the Library Director at his discretion. The system gift fund has never been audited. Melanie Quinn declined to provide information as to how the money was spent by the Library Director.

Resolution

WHEREAS the Fairfax County Public Library has not had a complete audit with a collection inventory since 1988;

WHEREAS there are discrepancies in county documents between 2006 and 2014 regarding collection holdings;

WHEREAS a new Library Director needs a full understanding of the finances and holdings of the library:

WHEREAS the system gift fund has never been audited;

WHEREAS President Jennifer McCullough of Fairfax County Public Library Employee Association called for more transparency in library operations in her July 9, 2014 statement to the Library Board;

Therefore

BE IT RESOLVED that the Fairfax County Federation of Citizens Associations requests an independent comprehensive fiscal audit of the Fairfax County Public Library.

BE IT RESOLVED that the Fairfax County Federation of Citizens Associations requests a complete collection inventory of the Fairfax County Public Library.

BE IT RESOLVED that the Fairfax County Federation of Citizens Associations requests an audit of the system gift fund.

Presentation at Sept 18 Federation Meeting

At the September Membership Meeting on September 18, Kris Unger and Elaine Tholen will discuss stream and watershed stewardship, including ways that civic associations can collaborate with the Friends of Accotink Creek (FACC) and other groups to support the local watershed. This presentation will become part of the FACC Community Presentation lecture series

They will cover

- Human impacts to the watershed, including pollution/litter, impervious surfaces/stormwater runoff, and habitat loss.
- FACC Spring and Fall Stream Cleanups (The Federation will be leading a cleanup on Oct 11, 3-5pm, near Fairfax Circle, behind the Home Depot).
- · Wakefield Run Stream Restoration.
- Collaborative grant example.

Elaine Tholen will present the school district's environmental stewardship program, Get2Green. She will talk about partnerships that make the program work and the possibility for community engagement. Elaine is an Environmental Educator at Fairfax County Public Schools, running the district's Get2Green Program. She is also a co-founder of NoVA Outside, an Alliance of Environmental Educators.

Kris Unger is the Primary Conservator of the FACC and a founding board member of the <u>Fairfax County Restoration Project</u>. He works with Lands and Waters on school-based watershed education and restoration projects.

Accotink Creek runs 26 miles through one of the finest wildlife corridors of rapidly-developing Fairfax County. The FACC is an all-volunteer organization dedicated to restoring, promoting, and protecting the Accotink Creek watershed, with the motto "Find just one other person who cares". They partner with volunteers, communities, schools, businesses, and government agencies to protect, restore, and improve the Accotink Watershed.

Re-planning Reston (Phase II)

Two (and only two) Community Meetings are scheduled to present and discuss the "strawman" Comprehensive Plan text for Reston Village Centers and residential neighborhoods. The formats of the meetings have not been finalized, but the County will have more information in the next few weeks. The meetings are:

- Saturday, September 13, 2014, tentatively from 8:30 am to 11:30 am: Community Meeting to Present and Discuss "Strawman" text for Phase II - Focus on Residential Neighborhoods. Location: Reston Association, 12001 Sunrise Valley Drive, Reston, VA 20191
- Saturday, October 18, 2014 (a change from the previous announcement), time and location to be determined. Community Meeting to Present and Discuss "Strawman" text for Phase II - Focus on Village Center

The schedule calls for publication of the staff's Recommended Comprehensive Plan Text and Staff Report by February 2015, with the hearing before the Planning Commission in April 2015 and the hearing before the Board of Supervisors in June 2015.

In general, the plan is to increase the commercial and residential densities.

Town of Vienna Redevelopment

The Town of Vienna is planning to redevelop the properties along Maple Avenue (Route 123), primarily by allowing taller commercial buildings. Enhancements will include more parking spaces, less congestion, and more bicycle and pedestrian paths. The Town's presentation can be found at

The decrease in congestion is expected without road widening, because more shopping will be local and because the traffic lights will be better timed. Buffer zones will protect existing neighborhoods. In general, the plan is to increase the commercial densities. The presentation should be of interest if your area is considering redevelopment.

Apartments in Your Neighborhood

The Planning Commission has voted to table the proposed zoning amendment that would have allowed Residential Studio Units (RSU's — small, zero-bedroom apartments) in residential areas. The Board of Supervisors will vote on the Planning Commission's recommendation after the August recess. The Federation's resolution:

Large Parties in Residential Areas

In response to complaints about large, noisy gatherings in residential areas, changes to the zoning ordinance were being considered; however, the Board of Supervisors deleted from proposed zoning amendments all references to large and noisy gatherings. There was considerable public outcry concerning limitations on the number of people but also, by setting a limit, encouraging large parties. Changes to the noise ordinance will be considered in September.

Residential Overcrowding

The County restricts the number of unrelated people who can live in a single-family residence (Zoning ordinance, Article 2, Part 5, Section 2-502). For a summary, see:

http://www.fairfaxcounty.gov/code/property/overcrowding.htm In general, a single household can house four unrelated persons or a family and two renters.

More and more complaints are heard about violations of the occupancy limits. The usual issue is parking, including parking in the street, on lawns, and in driveways. The County's Department of Code Compliance handles the violations; however, the evidence usually disappears during working hours. Its staff of 44 people handle approximately 9000 service requests per year, or approximately 4 requests per employee per week for all types of complaints, including unkempt properties, parked work vehicles, and unpermitted business functions.

Lake Accotink Trails

The Fairfax County Park Authority is planning trail improvements at <u>Lake Accotink</u> in Springfield, Va. (See Page 7 of this bulletin.) A public meeting to discuss the project will be held at 7 p.m. on September 24, 2014 at Cardinal Forest Elementary School cafeteria, which is located at 8600 Forrester Blvd Springfield, Va.

The Park Authority has concluded 50% engineering design for addressing current trail issues. The design focused on reducing the grade of the steep slopes and providing a safe pedestrian crossing at the dam outfall while allowing most flood stage waters to safely pass without stranding them. The design consists of an elevated walkway over the outfall. Other improvements would be incorporated into the spillway below the elevated walkway to help regulate future flood stage levels. This project will be partially funded from residual funding from the recently completed Lake Accotink dredging project. Design and permitting for the project is anticipated to be complete in late 2015 with construction commencing shortly thereafter.

New Business: Resolution on Infrastructure Joint Board of Supervisors (BOS)/Fairfax County Public Schools (FCPS) Committee: The Federation board, at its May meeting, recommended this resolution for consideration by the membership. Charlie Dane, the author, provided background information and rationale. The resolution:

- commends the members of the BOS/FCPS Infrastructure Committee for the cooperation shown in their work to address facility needs by both the County and FCPS;
- commends both boards for taking steps to implement the recommendations contained in the Committee's report;

- recommends the County and FCPS facilities staff, under the auspices of the BOS/FCPS Infrastructure Committee, develop common criteria for assessing facility condition and the urgency of renovations, jointly carry out inspections of both County and FCPS facilities, and ensure that square footage comparisons are of comparable entities; and
- recommends that the County hire a qualified, independent contractor to evaluate the County's design and construction process for the purpose of resolving the difference in costs per square foot and to assess FCPS and the County's utilization of administrative and warehouse space.

The resolution was adopted by unanimous voice vote.
