The committees conduct the bulk of their business by email and formulate positions and suggest actions for consideration by the Board and by the Federation members. They also provide inputs to the Federation's legislation and budget presentations.

Nutrient Management for Lawns

For a limited time, the Conservation District will work with Fairfax County homeowners associations (HOAs) and owners of individual properties to develop a 3-year nutrient management plan for their lawn areas. Individual properties must be 2 acres or larger. For HOAs, no size restrictions apply, but management plans will only be created for common areas.

The program is a modest cost-share in which the property owner or HOA pays for soil tests (\$10 each, plus mailing) which are processed by Virginia Tech. The results of the soil test(s) will be used by the District's Senior Conservation Specialist and Certified Nutrient Management Planner to develop the nutrient management plan and provide guidance on recommended fertilizer/lime applications, the size of the area to be treated, opportunities to reduce or eliminate grass, dates and duration of applications, a lawn care calendar, and opportunities for controlling weeds. If implemented, the plans will reduce lawn care costs and maintenance, and also support healthy local waterways, the Potomac River, and the Chesapeake Bay. To sign up, please contact Willie Woode at

Resolution on Advanced Academic Program

A resolution on the FCPS Advanced Academic Program was approved by the Federation Board on August 6, 2015. It will be presented for approval to the Membership at the September 17 meeting. The resolution states:

WHEREAS, many studies have shown that advanced learners are best served when grouped together in academic class-rooms; and

WHEREAS, FCPS provides services to advanced learners along a continuum of Advanced Academic services, ranking students according to their needs from Level I to Level IV, where Level IV represents students who require placement in a full-time Advanced Academic Program (AAP); and

WHEREAS, FCPS established "Centers" in which to gather Level IV AAP students from various base schools in order to ensure that these students would have an academic and socioemotional cohort not typically available in their base schools; and

WHEREAS, the increase in the percentage of Level IV-identified AAP students has led to concerns that, as former FCPS teacher of the year Vern Williams has commented, "kids aren't grouped as rigorously [and therefore top students do not have] more than just four or five peers close enough in ability to choose from to create a peer group;" 1 and

WHEREAS, the special needs of the top students within the AAP may significantly differ from the needs of other students within the program; and

WHEREAS, the 2013 George Mason University review of FCPS' AAP stressed the importance of "critical mass" for gifted students, defined in part by the presence of at least two classes per grade level or subject area; and

WHEREAS, no single elementary school consistently identifies 50 or more students per grade level as Level IV-eligible; and

WHEREAS, FCPS' most recent Capital Improvement Program (CIP) suggests establishing AAP Centers at Franklin Sherman and Chesterbrook Elementary Schools which would not admit AAP-eligible students from outside their base school populations, and thus do not meet the traditional meaning of a Center within FCPS; and

WHEREAS, some elementary schools provide Level IV AAP services to their base school students through a Local Level IV program; and

WHEREAS, parents of students at elementary schools that have a Local Level IV program have a choice of whether or not to send their AAP-eligible students to a Center; and

WHEREAS, one of the strengths of FCPS as a school system is that it provides essential services to families through a variety of programs, based on which program is right for each individual child, rather than a "one size fits all" approach to education,

THEREFORE, BE IT RESOLVED, by the Federation:

- 1. We recommend that FCPS reject the suggestion within the CIP to establish "One School Centers," such as those proposed at Franklin Sherman and Chesterbrook Elementary Schools; and
- 2. We recommend that FCPS direct the Department of Facilities and Transportation that in future planning, the CIP must take into consideration that the maintenance of a high-quality AAP

requires FCPS to offer the option of a strong Center-based education to all Level IV-identified students in elementary school.

Board-Approved Resolution

At its August 6, 2015, meeting, the Federation Board approved a resolution calling for Greater Cooperation between the Fairfax County Board of Supervisors and Fairfax County School Board. The resolution states:

WHEREAS, the Fairfax County Federation of Citizens Associations (Federation) appreciates the improved communication and cooperative efforts between the Fairfax County's Board of Supervisors (BOS) and the Fairfax County School Board (FCSB) members, and encourages continued discourse and additional collaboration, and

WHEREAS, future Fairfax County revenues appear to be inadequate for the needs of the desired County programs and public school programs, and

WHEREAS, the Federation believes that significant savings to the County's taxpayers can be achieved through even greater cooperation, and

WHEREAS, the Joint Budget Committee, which completed its report in 2014, has outlined the most comprehensive description of areas for cooperation that have the potential for the most significant savings, implementing these recommendations will depend upon the commitment of the County and School Boards.

WHEREAS, fair and comparable compensation is important to retention of quality County and FCPS administrative staff and support personnel, and

WHEREAS, competitive compensation is important for the retention of quality teachers, and

WHEREAS, elections for all County supervisors and members of the School Board are scheduled for the fall of 2015, and the election of supervisors and school board members supportive of expanded cooperative efforts will be critical to obtaining the savings necessary to continue present important County and School programs.

THEREFORE:

BE IT RESOLVED that the Fairfax County Federation of Citizens Associations (Federation) appreciates the improved communication between the Fairfax County's Board of Supervisors and the Fairfax County School Board members, and encourages continued cooperation, especially that which will enable additional efficiencies and/or cost savings to the Fairfax County taxpayer, and

BE IT FURTHER RESOLVED that the Federation, encourages District Councils, Citizen Associations, and other county citizen organizations to focus on the issue of joint Board cooperation, including compensation structure and merging of some activities and facilities, and to ask questions of all Board candidates in order to help determine each candidate's commitment to expanding cooperative undertakings.

Bicycle Accidents

According to the Journal of the American Medical Association, hospital admissions due to bicycle accidents have increased 120% since 1998, rising to 33,000 per year in 2013, with the largest increase being with those over the age of 45 (http://jama.jamanetwork.com/article.aspx?articleid=2432153). The CDC reports:

While only 1% of all trips taken in the U.S. are by bicycle, bicyclists face a higher risk of crash-related injury and deaths than do occupants of motor vehicles. In 2013 in the U.S., over 900 bicyclists were killed and there were an estimated 494,000 emergency department visits due to bicyclerelated injuries. Data from 2010 show fatal and non-fatal crash-related injuries to bicyclists resulted in lifetime medical costs and productivity losses of \$10 billion.

Despite the use of helmets, head injuries are the most common, increasing from 10% of the injuries in 1998 to 30% in 2013.

So, be especially careful when riding a bicycle.
