President's Message

Hello Members, Neighbors and Friends:

I start this month's letter with sad news. Our long time Federation colleague Dr. Charles (Charlie) Dane died on February 8th. There will be a service for Charlie on February 20th at 1 pm after a noon viewing at Fairfax Memorial Funeral Home (9902 Braddock Road, Fairfax, Virginia 22032). The Fairfax County School Board will also honor Charlie at an upcoming meeting in March.

The General Assembly in Richmond is in full swing, and the County's budget process has started up for this year's budget while congruently conducting Line of Business (LOB) reviews of each of the county's departments.

We are excited about our February 18th programming on the budget. Our TWO guest speakers will be the CFO's of the County (Joe Mondoro) and Public Schools (Kristen Michael). The evening's presentation will include updates on recent state legislative initiatives that have significant impacts on our property taxes, as well as discussion on the LOB reviews.

The Federation has been invited to testify at several different committees in the General Assembly in Richmond. This is a result of the great work done by the Membership in conjunction with the Legislative Committee in creating this year's Legislative Package. Education, environment and public safety issues have been foremost in the Fairfax Delegation's "invitations" — which the Federation has only been too happy to accept. And as all roads go to Rome, all legislation goes through the budget and/or appropriation committees, so we've attended and spoken at them too. I was honored that during a 45 minute meeting I personally had with the First Lady (Dorothy McAuliffe) she asked for a 2nd copy of our Legislative Package so she could

HOA/Condo Alert Stops Bill

SB 238 (Senator Petersen) would have removed authority to regulate businesses or to prohibit certain businesses, even if existing covenants grant such authority. Association leaders across the state put out an alert to contact members of the Senate General Laws and Technology Committee (GLTC). The alert stated that the bill had great potential to harm property values and that negating covenants would be unconstitutional. The senators heard from numerous homeowners and the GLTC voted unanimously on Feb. 8 to refer the bill to a General Assembly entity known as the Housing Commission for further study. The Federation did not take a position on the bill.



Federation Workshop on County Urbanization

As announced in the December/January bulletin, The Federation and the Fairfax County Planning Commission had workshop meetings on January 13 and January 20, respectively, on the county's program to "urbanize" the county. "Urbanizing" means increasing the population density and the amount of commercial floor area.

Two of the concerns expressed at the Federation meeting were allayed by comments from the commissioners: (1) Commissioner Hart voiced his concern over the twice-used phrase "in the discretion of the Board" as used in the proposed FAR 5 zoning ordinance amendment. (2) Commissioner Sargeant said that the Planning Commission does want stable neighborhoods.

The county will continue with its urbanization program in selected areas, although increasing the maximum FAR from 2.5 to 5.0 remains under consideration.

Budget and Finance: Our Budget and Finance Committee will be inviting a representative from the County Executive's Office to attend its March meeting to address the County Budget.

The **MV Tree Commissioner** wants to arrange an educational workshop for district residents about the value of trees. It will be open to the public. The date to be determined.

Public Safety and Transportation Committees: These 2 committees are working together to determine what can be done to mitigate the traffic (accidents and speeding) along the GW Parkway from Old Town Alexandria and Ft Belvoir. The Chair of Transportation Committee is in communications with the National Park Service Parkway Superintendent and has requested accident data.

Environmental and Recreation Committee: A represented from the County Animal Control (AC) Division spoke to the group about wildlife management and the ongoing review regarding where the AC division should be organizational placed--stay with the police department or move under the Animal Shelter. (The AC function of the City of Alexandria is under the Alexandria Animal Shelter, which works closely with the police to ensure animal safety and protection).

Supervisor Dan Storck (newly elected MV District Supervisor): Supervisor Storck spoke to the MVCCA General Council about his plans for the District and how he intends to interface with the citizens. He's established regular office hours, including some evenings, for discussions with citizens on a one on one basis. He will host his first Town Hall meeting Feb. 27th.

Resolution Resubmittal: March 1, 2016 the BOS will review of the County's pest management program. Therefore, the MVCCA's 2014 resolution to "Oppose the Insecticide Spraying of the Canker Worm" was forward to Supervisor Storck for action. The cover letter to the resolution reaffirms the MVCCA's position to have the spraying stopped and the funds transferred to other programs such as the removal of invasive vines, as a way to protect our trees.

MVCCA Co-Chairs: On Feb 11, 2016 the Co-Chairs will be participating with the Mount Vernon-Lee Chamber of Commerce in the 2016 Community Covenant Renewal Signing Ceremony with Ft Belvoir. This annual event reaffirms the partnership between the citizens and businesses of MV and Lee Districts and the military families and the Fort Belvoir Post.

Citizens Associations for many years, briefly serving as Chair of the Land Use Committee and later as First Vice President. For almost ten years, he served as Chair of the Federation's Education Committee. He was elected Treasurer of the Federation in 2001 and immediately took action to improve the control and accountability of the Federation's funds and to arrange for its first audit. He was equally concerned and involved with the Federation's many activities and products. Charlie was dependably available to review resolutions, policies, minutes, letters, and testimony and greatly improved the accuracy and logic of these products.

In his more than 20 years of activity in the Federation, Charlie worked on quality education for the County's youngsters and the structure and resources necessary for providing this high level of education. He established excellent working relationships between the Federation and the FCPS and was highly respected for his participation in various matters affecting the operation of the school system. At School Board retreats, work sessions, and selected committee meetings, Dr. Dane offered ideas on educational and administrative practices to improve public education. He served on the Fairfax County School Board's Advisory Committee of Human Relations, as co-chair for two years. He was a member of the Fairfax County Public School Superintendent's Business and Community Advisory Council. He was on the task force for selecting Dr. Jack Dale's successor as superintendent. He participated in the annual review of scholarship applications submitted to College Access Fairfax. In 2015 Charlie represented the Federation on the Superintendent's Budget Committee Task Force.

In addition to education pursuits, Dr. Dane served for eight years as the Braddock District representative on the Fairfax County Commission on Organ and Tissue Donation and Transplantation and served as the Commission's Vice Chair. He also participated as a member of the Braddock District Citizens Budget Committee. As a retired federal employee (Chief, Office of Scientific Authority, U.S. Fish and Wildlife Service), he was a member of the National Active and Retired Federal Employees Association and served as Treasurer, Vice President, and President of the Annandale NARFE Chapter 1159. Dr. Dane served as Area Improvement Chair of his Stone Haven Civic Association and coordinated the association's biennial home tour event to encourage others to remodel and improve their homes and yards. Clearly, we at the Federation are not the only ones who will miss Charlie.

Charlie received the Federation's 2010 Citation of Merit award. In 2011, in recognition of their extensive community service, Charlie and his wife, Dottie, were Lord and Lady Fairfax from Braddock District.

Library Director

- 1. Library Director Sam Clay will be on extended leave until his retirement March 22, 2016.
- 2. The assistant director position has been recreated by the county and will be filled from current FCPL staff. The assistant director will be the acting director. Without an MLS librarian in charge as library director, FCPL is not eligible for state aid. The current co-deputy directors, Katie Strotman and Melanie Quinn, do not have MLS degrees.
- 3. Advertising for the new library director position is planned for the end of January. We were told that previous experience as a library director will not be necessary. It was announced at the last Library Board meeting that Deputy County Executive Dave Molchany and Library Board Chair Charles Fegan will do all the preliminary evaluations of candidates as they did before. Not sure if a Library Board search committee will be appointed this time.

Shouldn't this be provided by Economic Development Authority and the Chamber of Commerce? Will the library hire business librarians in each of the branches that provide work space for entrepreneurs?
