Presentation: The Ad Hoc Police Practices Review Commission. Public Safety Committee Chair, Patrick Smaldore, introduced State Delegate Simon, who was the Chair of the Mental Health and Crisis InterventionTeam subcommittee. Delegate Simon briefed us on the history and layout of the whole Ad Hoc Commission, but then gave us specifically the outcomes and current status of the recommendations from the subcommittee he chaired. The recommendations from his subcommittee and the whole Ad Hoc Commission were given to the Board of Supervisors. Delegate Simon answered questions from the members until 8:50pm.

Administrative: President Thompson swore-in George Becerra as the Recording Secretary. President Thompson also announced that there was an opening for the Correspondence Secretary position.

Meeting Minutes: October's Membership meeting minutes was passed, as amended, unanimously.

Treasurer's Report: No report.

Membership Report: First Vice President, Ed Wyse, presented the current membership numbers, as of the end of June 2016: There are 57 members, in which, 16 have not renewed, and 41 have renewed.

Here is the Environmental report I just sent to the Federation Board:

I've been busy since the last Membership meeting and so has Monica.

On 29 October I attended the Friends Groups Informal Meeting. The idea was to get all the "Friends" groups such as the Friends of Accotink Creek, the Friends of Huntley Meadows, Friends of Fairfax County Archology ... The meeting was organized by Susan Voss from the Friends of Green Springs (FROGS). The group has in common that they all have relationships with the County Park Authority

- There was a presentation by Sandy Stallman from FCPA about the Park Bond Referendum and how it was developed based on the Parks Needs Assessment process. One item I had not heard about was that it included investigating building a building to house the County's 3 million archeological artifacts. It might be interesting to have a meeting about archeology in the County.
- After the Parks Authority representative left the group discussed the County's plans to revise the agreements with the groups (including the Friends of Accotink Creek) to include such provisions into the new agreement to require that the funds coming to the Friends groups should all be donated to the County Parks Foundation. Needless to say the group was outraged.
- There was an excellent presentation by the Friends of Huntley Meadows representative about their successful efforts suing Dominion about a new power transmission line along the southern edge of Huntley Meadows. This could be a good Federation, Lee District Council or any District Council that has a concern about Dominion Power lines.
- I also learned about the upcoming 275th anniversary of the founding of the County to be celebrated on June 17, 2017. We should have a presentation about this too, perhaps in connection with the discussion about Fairfax Archeology.
- The organization was originally founded as the Federation of Friends Groups but has been dormant for many years.

With the Federation's legislative position on renewable power, I've been working on finding out more on the subject and developing relationships with possible supporters.

- On November 7th, just before the election, I attended a Solarize NOVA Loudon presentation by the Local Energy Alliance Program (LEAP) about a program that is set up in Loudon County to help homeowners get solar collectors. The same group also has a program in Vienna (and near-by neighborhoods). LEAP does energy audits (mostly funded by Dominion) and will act as the general contractor for home solar collector installations, reviewing the siting, issuing RFQs to approved contractors and helping with the selection of an installation contractor. This could be a program that we could recommend that Fairfax County support. For more information see www.leap-va.org.
- On November 10th, just after the election, I attended a Solar School Initiative meeting set up by the Sierra Club, again in Loudon County, to try to get the County to install solar collectors on Loudon County Schools. Albemarle County has a Power Purchase Agreements (PPA) contract with Secure Futures to install solar collectors on County Government Buildings (including schools). There is no capital costs to the County and the power costs are lower than if you were to buy the power from Dominion. Also they can install the collectors on flat roofs without any roof penetrations. Susan Stillman from the Sierra Club said that Fairfax County is looking at setting up their own PPA contract. This should be something we can support. For more information you should contact Susan Stillman (stillman.susan@gmail.com).
- Finally in this series, I attended a panel discussion at George Mason University on November 15th "Climate & Politics, What's Next for Virginia". Dr. Edward Maibach, the Director of George Mason's

Center for Climate Change Communication keynoted the session with an excellent presentation about how the perception of climate change has changed in the 10 or so years that they have been conducting National polls on the issue. They have collaborated with a Yale University polling group that have downscaled the polling data so that you can get an idea of the perception of the issue to in communities down to the County or congressional district level (see http://www.climatechangecommunication.org/climate-change-opinion-map/). The panelists included a reporter (Natasha Geiling from Think Progress), a Capitol Hill lobbyist (Joshua Sak from the National Wildlife Federation), a pastor (Laura Martin from Rock Springs Congregational United Church of Christ representing Interfaith Power & Light), a Richmond lobbyist (Walton Shepherd from the Natural Resources Defense Council), a former foreign service officer (Ray Martin from Christian Connections for International Health) and a Real Estate broker from the Hampton Roads area (Rich Sterling). We should definitely reach out to the Interfaith Power & Light folks and the Hampton Roads real estate community for support, they can get in doors that we may have difficulty getting a proper hearing with.

Green Breakfast, November 12. This month's Green Breakfast featured Eric Hollinger from the National Museum of Natural History. Eric's presentation was "Greening the Smithsonian" and would be an excellent presentation at any Federation, homeowner or district council meeting. Eric is a resident of Fairfax County and has done extensive research on the impediments to recycling and what happens to the waste after it is collected. If you have Eric for a presentation I suggest you also invite someone from the Public Works like Pam Gratton, because while Eric knows a lot about recycling from a company perspective, I'm not sure that he understands how it is done in Fairfax County.

Friends of Accotink Creek meeting, November 15. The key topics that may be of general interest:

- The FAcC is planning a day of action (protest) in front of the International Bottled Water Association in Alexandria, April 10. They are currently working on getting the proper permitting.
- The FAcC will be having their elections at the December 20th meeting at the Audrey Moore RECenter, 7-9 pm.

Monica, could you add something about what you have been up to? I meant to include that in the e-mail I sent the Board but forgot.

The Supervisor's office and the Braddock District Council (BDC) jointly sponsored a HOA/Civic Association Symposium on November 9th. The purpose was to have informal discussions on issues of concern to the Associations. A good turnout resulted in lively discussions on various issue; two of the more prominent were (a) the impact of the non-passage of the meals tax on the operations of the schools, and (b) the effects of (1) closure of the recycle drop off sites at Wakefield Park and In Mason District, and (2) the banning of using plastic bags for yard waste effective in 2017.

The BDC's special committee on Aging in Place held its monthly meeting on November 16th. The featured presentation by Marcy Bartlett was "Building Together" on repairs or modifications to lower income homeowners.
